

# RATEFAST SERVICES AGREEMENT

#### Last Modified February 25th, 2020

RateFast is a data collection and data formatting web-based application that assists health care professionals in organizing information and providing independent impairment ratings consistent with the AMA Guides to the Evaluation of Permanent Impairment.

RateFast is a dba owned and operated by Alchemy Logic Systems, Inc. (referred to as "ALS", "we", "our", or "us"). Formatting and impairment calculations generated by RateFast are recommendations based on information provided by the user, and the user is ultimately responsible for the opinions of their report, and understanding the AMA Guides to the Evaluation of Permanent Impairment and their applications as they apply to state guidelines, policies and regulations.

Review these terms of RateFast Services Agreement ("Agreement") thoroughly. This Agreement is a legal agreement between you and ALS. By accepting electronically (for example, clicking "I Agree") or accessing or using RateFast, you agree to these terms. If you do not agree to this Agreement, then you may not use RateFast.

# 1. TERMS OF USE

This Agreement describes the terms governing your use of RateFast services provided to you on this website, including reports and content (collectively, the "Services"). It includes by reference:

#### A. OVERVIEW

Fees are charged to the Visa, MasterCard or American Express credit card on file at time that report information is submitted, or, if approved in writing by ALS, fees are due upon receipt of invoice.
- B. You agree to pay any and all prices and fees due for Services purchased at this Site at the time you order the Services. All prices and fees are non-refundable unless otherwise expressly noted, even if your Services are suspended, terminated, or transferred prior to the end of the Services term. ALS expressly
